

**ORDINANCE NO. 1568**

**AN ORDINANCE TO AMEND CHAPTER 11 – MOTOR VEHICLES AND TRAFFIC –  
ARTICLE IV – STOPPING, STANDING OR PARKING BY AMENDING SECTIONS 11-153  
AND 11-191 REGARDING NO PARKING; LIMITED PARKING ZONES AND PENALTY  
FOR PARKING TIME VIOLATIONS; DELINQUENT FEE PENALTY**

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MADISON, SOUTH  
DAKOTA:

That Sections 11-153 and 11-191 of the Revised Ordinances of the City of Madison, also known as the  
Code of Ordinances, be amended to read as follows:

**Sec. 11-153. No parking; limited parking zones.**


- (a) Wherever upon any street or avenue in the city the curb is painted with a broken yellow stripe, or an appropriate sign is erected under the direction of the City Commission or designee, such broken stripe, marking or sign shall indicate a limited parking area or zone, the extent of such limitation to be indicated by signs at the end of each such limited area or zone and it shall be unlawful for any person to park a vehicle adjacent to such limited parking zone for a longer period than indicated upon such signs.
- (b) Wherever upon any street or avenue in the city the curb is painted with a solid yellow stripe or an appropriate sign is erected under the direction of the City Commission or designee, such stripe, marking or sign shall represent or indicate a "No Parking" area or zone and it is unlawful for any person to park a vehicle adjacent to such marking.
- (c) Tickets for violation of this section shall be the responsibility of the registered owner of the ticketed vehicle.


**Sec. 11-191. Penalty for parking time violations; delinquent fee penalty.**

- (a) Any person who operates a vehicle found in violation of this Section shall within seventy-two (72) hours from the time when the notice of violation was attached to such vehicle, pay to the office of the city Finance Officer, as penalty for and in full satisfaction of such violation, the sum of twenty-five dollars (\$25.00).
- (b) If said person fails to pay said sum within said seventy-two (72) hours, he or she shall, within two (2) weeks from said seventy-two (72) hour period, pay to said officer as penalty for and in full satisfaction of said violation the sum of fifty dollars (\$50.00).
- (c) Upon failure of said person to pay either of said sums to said office within the time periods indicated and upon conviction of a violation of this Section, said person shall be guilty of committing a petty offense.
