MUST READ AND SIGN BACK / WAIVER FORM

CC WELLNESS STUDIO TERMS AND CONDITIONS

1. CC Wellness Studio access cards are valid upon completion and signing the CC WELLNESS STUDIO ACCESS AGREEMENT and payment of the KEY FOB issued by the Community Center.
2. An access card must be purchased for each member utilizing the CC Wellness Studio. Members 14 years of age or older are eligible to receive an access card.
3. A cancelled access card must be repurchased to become reactivated
4. Anytime the primary member on a Community Center membership is cancelled, the primary member and any person on their membership contract will have their CC Wellness Studio access card cancelled. Pay-in-full memberships to the Community Center renewed within 30 days of their cancellation will have their CC Wellness Studio access cards reactivated without paying a reactivation fee
5. Anytime a DSU Student becomes ineligible to access the Community Center through their DSU student membership their CC Wellness Studio access card will be cancelled. DSU students no longer eligible for a student membership will have 30 days to purchase a Community Center Membership and have their access card reactivated to the CC Wellness Studio without paying a reactivation fee.
6. If you are found to be sharing your access card with other individuals (members or non-members) or letting other individuals into the CC Wellness Studio the CC will immediately cancel your access card and you shall be accountable for any damages that occur.
7. If you should happen to lose or misplace your CC Wellness Studio access card you must report the lost to the Community Center director immediately. You will be held financially accountable for any damages that occur until your card is cancelled. A new access card will need to be repurchased.
8. Any member deemed abusing or neglecting equipment and or property will be financially responsible for replacement of equipment or repairs to the property.
9. Failure to follow posted hours of operation or CC Wellness Studio policies and rules will result in disciplinary actions up to cancellation of CC Wellness Studio access card
10. All terms and conditions of your Community Center membership shall remain in full force and effect and shall apply to your access to the CC Wellness Studio
11. The Community Center is not responsible for lost or stolen items.
12. The Community Center Governing Board reserves the right to increase access card fees, implement access card renewal fees, or implement any other type of fee structure for use of the CC Wellness Studio without advance notification.
13. The Community Center reserves the right to remove or suspend any member's access to the CC Wellness Studio for any reason.
